School Responsibilities

Micanopy Middle School, Inc. will:

- 1. Provide high-quality curriculum and instruction in a supportive and effective learning environment that enables the participating children to meet the State's student academic achievement standards as follows:**

- *Provide an environment that is safe and conducive to learning.*
- *Hire highly qualified teachers and paraprofessionals.*
- *Utilize research-based curriculum materials that correlate with the Sunshine State Standards/Grade Level Expectations.*

- 2. Hold parent-teacher conferences annually. Specifically, those conferences will be held:**

- *For parents of students attending Micanopy Middle School.*
- *Regular parent-teacher conferences are scheduled at the end of each grading period during the school year.*
- *Parents are encouraged to request a conference at any time they deem it necessary.*

- 3. Provide parents with frequent reports on their children's progress. Specifically, the school will provide reports as follows:**

- *Parents are provided with daily academic and behavioral progress reports through the use of a daily check-sheet.*
- *Interim progress reports are sent home every grading period.*
- *Report cards are distributed every nine weeks.*

3. Provide parents reasonable access to staff. Specifically, staff will be available for consultation with parents as follows:

- *All staff members are available before school on a daily basis and after the 2:45pm teacher's meeting on Wednesday.*

4. Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities, as follows:

- *All parents are encouraged to volunteer in their child's classroom on a regular basis.*
- *Parental involvement is solicited for specific classroom activities when necessary.*

Parent Responsibilities

We, as parents, will support our children's learning in the following ways:

- *Make sure my child attends school on a regular basis.*
- *Make sure my child arrives to school promptly and is prepared to do his/her best each day.*
- *Set aside a specific time and place for my child to work on homework assignments and review it upon completion.*
- *Read, sign and promptly return any progress reports, notes, or other school or school district information that requires a parent/guardian signature.*
- *Monitor the amount of television my child watches.*
- *Promote positive use of my child's extracurricular time.*
- *Volunteer in my child's classroom on a regular basis.*
- *Be an active member of the school's Parent-Teacher Organization.*

Student Responsibilities

We, as students, will share the responsibility to improve our academic achievement and achieve the State's high standards. Specifically, we will:

- *Attend school promptly and regularly.*
- *Complete class and home assignments daily and ask for help when I need to.*
- *Read at least 30 minutes every day outside of school time.*
- *Give to my parents or the adult who is responsible for my welfare all notices and information received by me from my school every day.*
- *Be prepared for class with all the necessary materials and supplies.*
- *Follow all school and classroom rules.*
- *Not display disruptive activities that impede others from learning.*

Additional Required School Responsibilities

Micanopy Middle School, Inc. will:

- 1. Involve parents in the planning, review, and improvement of the school's parental involvement policy, in an organized, ongoing, and timely way.**
- 2. Involve parents in the joint development of any schoolwide program plan, in an organized, ongoing, and timely way.**
- 3. Provide information to parents of participating students in an understandable and uniform format, including alternative formats upon the request of parents with disabilities, and, to the extent practicable, in a language that parents can understand.**
